



## GIFT AID FOR DOVER GYMNASTICS CLUB

Dear Parent, we would like to inform you that now Gift Aid is an option to boost donations to charities like ours and this is funded by the Government. Membership and some fees payments made by you as parents to Dover Gymnastics Club are now eligibility for Gift Aid.

In order for the club to access these Benefits, we need the form below to be completed and signed by the person at home who is a UK Taxpayer. If there is nobody at home that qualifies, it is important for us to have this form returned but with the DOES NOT QUALIFY box ticked.

The gift aid rules will allow us to claim back gift aid for up to four years (initially) so whether your child is a new member or you have been members for 4 years or more this will have a massive benefit to the club now and place us on a great financial footing going forward to do many things including keeping fees as low as possible.

We will only know what the benefit will be once we collect all the forms and can present the initial claim to HMRC Charities.

The form will be sent to you or you can pick it up from the office.

We will fill the part related to your membership payment

## Charity Gift Aid Declaration
